Prior to joining Cristo Rey Atlanta, Bill served as the President of the Saint Joseph's Mercy Foundation, where he was responsible for all fundraising activities for Saint Joseph's Hospital and Saint Joseph's Mercy Care Services. He also served as the Chief Mission Officer for Saint Joseph's Health System, where he was responsible for maintaining the Catholic identity of the hospital, including patient quality, pastor care, ethics and volunteerism.
