Buzz is currently serving on the Advisory Board for Smokey Powell School at the Academy for the Blind in Macon. Recently, Buzz was appointed by State Superintendent of Schools, Richard Woods, to Vice Chairman of the Georgia Foundation for Public Education (GFPE).

Since 2006, Buzz has been honored to be accepted in the elite company of the Atlanta Estate Planning Council. In 2005, as a Charter member, Buzz completed the certification for Kingdom Advisors previously the Christian Financial Professionals Network (CFPN), as well, and was a charter member.
